### Administration Report – Sandi Brown

- COVID-19 Health Mandates by County Sandi started her report answering questions for the Browns.
   She reiterated that CEC will comply with all local county and state health requirements. As CEC spans several different counties those requirements will differ, accordingly. (Such as upcoming county mandates in Denver.) Currently, there is no local or state mask mandate for Fort Collins, therefore CEC will maintain the policy of parent choice regarding masking for students, -- while encouraging students and staff to wear masks when indoors.
- Axiom Politics Sandi briefly shared about our CEC Lobbyist activity.
- CECCS Dedication of Building to Deborah Hendrix September 22<sup>nd</sup> @ 5p-6:30p Sandi invited all to attend and celebrate the upcoming CECCS Middle school dedication ceremony!
- Approved School Clubs Sandi shared the list of currently approved and operating clubs.
- School Performance Data Summary -- Sandi touched on our Schools Performance Data Summary, including:
  - High Schools showed an increase in academic achievement.
  - Students of poverty struggled with test scores.
  - COVID affected student achievement, especially among students of poverty.
  - Looking at CECFC data -- CECFC outperformed both local and state mean scores.

- Audit Update Cameron briefly reported on our Audit status.
- Grants Update -- Cameron gave us info on the CECFCMS BEST Grant, the CCSP Grants for CECCW, CECCS, and CECW, and the ESSER II and ESSER III Grants.
