Administration Report – Sandi Brown

- Academics
 - CDE released the School Performance Framework reports. Ryan M. from CSI will attend the November 18 Board meeting to present the data to the Board.
 - The 2021 Annual Report for Dual and Concurrent Enrollment in Colorado highlighted the top 10 schools with the highest number of students participating in concurrent enrollment. CEC Fort Collins topped the list for the 3rd consecutive year, and CEC Parker ranked #10.

 Student Liaison Presentations – Student representatives from CEC Castle Rock, CEC Inverness, and CEC Parker shared about their school's culture and highlighted upcoming school events/activities with Board members. Laura thanked the students for attending the Board meeting.

Human Resources

 CEC has nearly 500 employees but has a number of unfilled positions such as bus drivers, substitutes, and mental health providers.

Marketing

- <u>CECI Featured on 9News "Cool Schools" September 30</u> A video clip was shared with the Board during the Student Liaison Presentations.
- o CEC's website is in progress of a refresh with a focus on easier navigation.
- o Marketing Plans for each school will be completed by November 1, 2022.
- o CEC launched its first Alumni Outreach focusing on CEC Parker.

Operations and Facilities

- o Each CEC school has a robust Safety Response Protocol in place.
- o Staff from each CEC school attended CPI training through Crisis Prevention Institute.
- CEC has a 3-year Safety and Security Plan in collaboration with facilities for upgrades to door locks, cameras, barriers, glass protection, etc. There is a possibility of Federal grant money being available and CEC is prepared to apply.
- Presentation on Paid Family and Medical Leave Insurance (FAMLI) Program Amber DeCarli
 - The purpose of the FAMLI presentation was to inform the Board about the program so that the Board could discuss and determine which of the three program participation options was best for CEC.

 - Uli presented an overview of CEC's first Network-combined audit. She noted that GASB 87 (accounting changes for leases) was implemented this year. Uli pointed out that the auditors gave CEC an unmodified opinion. Overall, the audit was completed in record time.
 - Both Uli and Cameron M. extended their appreciation to CEC's Finance Department for all their hard work.
